The mission of the Madison Education Foundation (MEF) is to support, maintain, and enhance educational programs and activities for all students in Madison School District #321. Philanthropic and volunteer assistance from individuals, business, and community partners allow the Foundation to further advance and support the educational mission of Madison School District.

The money for this grant is awarded from limited funds made available through interest in the endowment fund and as those endowment funds grow, more grants will be accommodated.

Grant Cycle and Deadlines:

- ♦ Grant Cycle Opens: Tuesday, September 3rd, 2024
- ♦ Grant Cycle Ends: Thursday, October 31st, 2024 (4 p.m.)
- Grant Applications must be submitted by the <u>end of the day to Alisha Martin in the District Office</u> in person or through District Mail system to be considered.
- ♦ Applicant <u>must be currently contributing</u> to the Madison Education Foundation Permanent Endowment Fund to be considered.
- ♦ Late applications will <u>not</u> be considered.
- ♦ You will be notified around November 15th, 2024 of the status of your grant.
- Grant requests not filed on the Official MEF Grant Application (see next page) will not be considered.

Grant Amounts

Applicants who have a project to increase and enhance student learning are invited to apply for up to \$1000.00.

Grant Requirements

- Only administrators, faculty, and staff of the Madison School District 321 may apply for a grant.
- ◆ Completely fill out the MEF Grant Application Form (see next page) and deliver to Alisha Martin at the district office by the deadline.
- ♦ A brief written update must be submitted that describes how your project , that was funded by the MEF, went. <u>It also must include pictures.</u> Please submit this report as directed in the grant notification letter.

Grant Restrictions:

- ♦ Any funds awarded must be used within twelve (12) months from the date awarded. Any unused funds must be returned to the Madison Education Foundation.
- All materials and equipment purchased with MEF Funds will become the property of Madison School District 321.
- Any projects that fall under normal operating expenses for Madison School District, including salaries, will not be considered.
- Consumables will be considered as part of a larger project on a case by case basis. These could include: lab materials, activity materials, subscriptions and other things.
